- The Eligible Applicant must be able to provide their proof of payment (processed cheque, credit card statement, etc.) for ALL invoices.
- Invoices and proof of payment should be issued in the name of **APPLICANT NAME**. Invoices must be itemized with the cost of each item clearly identified.
- Cash payments will not be eligible unless accompanied by an official company voucher and proof of payment.
- Barter/exchange transactions are not eligible under the Program.
- Transactions between persons related by blood, marriage, adoption, common-law relationships, or close-business ties are not eligible.

**Project and Eligible Expenses**

To be eligible for reimbursement, the proofs of purchase for Eligible Expenses must be between April 1, 2023 and End Date (the “**Project Term**”). Items must be in the Eligible Applicant’s possession and/or installed no later than six months after the end of the Project Term.

**Request for Payment and Final Report**

To be eligible for payment, **each Eligible Activity must be complete by the purchasing deadline stated in the Project Work Table.** “Completed” means that all Program-funded items have been fully bought and paid for. You must complete and submit the Final Report which includes the attached Final Report Form as well as supporting documents such as invoices, proofs of payment, and Environmental Farm Plan certificate or completion letter on or before the Final Report Submission Due Date stated in the Project Work Table. You are not eligible for payment for the Grant and no payments will be made if the Final Report and the required supporting documentation are not submitted, to the satisfaction of the Minister.

The Minister may require that any reports be reviewed, assessed and reported on by the Eligible Applicant’s auditors. Upon request by the Minister, you must elaborate on any particular aspect of any report in a timely manner.

The determination of whether an expense constitutes an Eligible Expense is at the sole discretion of the Minister. The Minister has the absolute discretion to determine any payments due under this Program.
