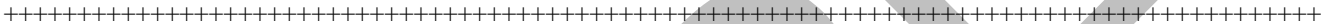

CONVICTION NOTE

The information recorded in this Part reflects convictions. A "conviction" is an offence that has resulted in a conviction being registered in the courts. Events are shown in order of offence date, with the most recent date shown first.

Points ranging from 0 - 5 are assigned to a conviction depending on the severity of the offence, 5 being the most serious offence. As an example:

- Faulty lights, not resulting in out-of-service 1 point
- Speed, 21-30 km/hr over posted limit 2 points
- No permit or contravene conditions on permit 3 points
- Drive while disqualified 5 points

Conviction points, Administrative Penalty points, CVSA Failure Rate, Collision points over a 12 month period, and the carrier's average fleet size over a 12 month period are used to establish the carriers Risk Factor score (R-Factor). Alberta Transportation and Economic Corridors will intervene with those carriers with an unacceptable R-Factor score.

ADMINISTRATIVE PENALTY NOTE

The information recorded in this Part reflects administrative penalties, as issued under Alberta's Provincial Administrative Penalties Act.

An "administrative penalty" includes a fine and any other administrative consequence, including, without limitation, a sanction, restriction, prohibition, requirement, condition, suspension, disqualification or cancellation imposed on a person for contravention of a prescribed enactment, but does not include imprisonment.

An "administrative penalty" includes, without limitation,

- a failure to comply with a restriction, prohibition, requirement, rule, direction, order, term or condition imposed by or under a prescribed enactment,
- conduct that is subject to sanction under a prescribed enactment, and
- any other action prescribed as a contravention under the Provincial Administrative Penalties Act.

As of December 1, 2020, Alberta's impaired driving laws were strengthened with the introduction of the Immediate Roadside Sanctions (IRS) program that includes serious, immediate and escalating consequences for impaired drivers.

- As part of the Immediate Roadside Sanction (IRS) program, Alberta has strengthened its impaired driving laws.
- A new administrative penalty for commercial drivers has been introduced, IRS Zero Commercial, which takes a zero tolerance approach to drugs and alcohol for drivers who are operating a commercial vehicle.
- For purposes of section 88.02(1) of the Traffic Safety Act and issuance of the IRS Zero Commercial penalty, "operating a commercial vehicle" means operating a:
 - a. commercial vehicle or combination of commercial vehicles that is registered for a gross weight of more than 11 794 kilograms, or
 - b. commercial vehicle that has a manufacturer's seating capacity originally designed for 11 or more passengers, including the driver.

As of June 2022 month-end carrier monitoring, administrative penalties issued for impaired driving charges are included in the Risk Factor score (R-Factor).

The information recorded in this Part reflects all Levels of inspections conducted by law enforcement agencies under the Commercial Vehicle Safety Alliance (CVSA) program. All levels of CVSA inspections (1 through 5) will be used to determine the carrier's out-of-service rate.

- Level 1 - is a complete inspection of vehicle and driver
- Level 2 - a walk around inspection of vehicle and driver
- Level 3 - is a driver inspection only
- Level 4 - is a one time examination of a particular item
- Level 5 - is a complete inspection of the vehicle only

A CVSA inspection will result in one of the following:

- Pass- no CVSA defect(s) found, decal issued
- Requires attention- defects found, none were out of service, no decal issued
- Out-of-Service- one or more out-of-service defects found, no decal issued

On Part 4 - CVSA Inspection Detail, Out Of Service defects (shown as an "O" on a CVSA Inspection Form) and Requires Attention defects (shown as an "X" on a CVSA Inspection Form) will be displayed separately. The number of defects detected will be displayed under the vehicle number and across from the defect category / description.

Conviction points, Administrative Penalty points, CVSA Failure Rate, Collision points over a 12 month period, and the carrier's average fleet size over a 12 month period are used to establish the carrier's Risk Factor score (R-Factor). Alberta Transportation and Economic Corridors will intervene with those carriers with an unacceptable R-Factor score.

CVSA Failure Rate is calculated as ratio of combined Out-of-Service inspection number with quarter of Required Attention inspection number to total number of CVSA inspections.

Prior to January 1, 2024, the collision threshold for property damage was \$2,000 or more.

Property damage collisions that occurred in the last 12 months based on the \$2,000 threshold will continue to appear on the profile and be included in carrier monitoring for the 12 month period based on the event date. After the 12 month period, only property damage collisions with a property damage of \$5,000 or more will appear on the profile and be included in the risk factor score.

Conviction points, Administrative Penalty points, CVSA Failure Rate, Collision points over a 12 month period, and the carrier's average fleet size over a 12 month period are used to establish the carrier's Risk Factor score (R-Factor). Alberta Transportation and Economic Corridors will intervene with those carriers with an unacceptable R-Factor score.

Where a carrier has requested a collision review and the collision was determined to be "supported", the points will be removed from the Carrier Profile and the event will not be considered in determining the carrier's R-Factor score.

All reportable collisions appear on the profile as "not supported/not reviewed" with the appropriate corresponding

Through the Carrier Profile system, conviction, administrative penalty, CVSA inspection and collision information is analyzed and combined to determine a carriers Risk Factor score (R-Factor). Each area's contribution to the R-Factor can be viewed on the "Monitoring Summary" page.

Alberta's National Safety Code monitoring program is designed to identify and intervene with 5% of bus and truck carriers that have the worst R-Factor. In establishing which 5% of carriers make up the department's monitoring list, fleet type (bus or truck) and fleet size are considered. Using this method carriers are compared with others that have similar fleet types and fleet ranges.

Once on the department's monitoring list, the carriers R-Factor score is further evaluated to determine what monitoring stage they are at. Monitoring stages 1 through 4 have been established, 4 being the stage that represents the greatest risk to the public. Alberta Transportation and Economic Corridors will intervene in a progressive manner with carriers on the monitoring list in an effort to create positive change within their operation.

The monthly compliance data shown in the Monitoring Part is only for the months between the Profile Period Start and End Dates. Carriers may find it valuable to review this page to establish if the contributions of the convictions, administrative penalties, CVSA inspections and collisions to the R-Factor score are rising, declining or staying the same. This type of information may assist carriers in evaluating the effectiveness of their safety and maintenance programs.

Note: Risk Factor Score Changes

As of May 1, 2024, the risk factor scoring process is refined to improve the precision of carrier monitoring to identify the 5% high-risk carriers operating in Alberta. Risk factor score refinements take effect for April 2024 month-end monitoring. Carriers may find that their risk factor score has changed from March 2024 to April 2024 month-end, as a result of the refinements. The monthly compliance data shown in the Monitoring Part is only for the months between the Profile Period Start and End Dates.

- greater precision in calculations of average fleet over a 12 month period, which aligns with the 12 month period for safety event data;
- changes in fleet groupings for more equitable distribution of carriers; and
- failure rate is calculated as CVSA inspection points per vehicle based on the carrier's average fleet.

The Operating Status (OS) assigned to a carrier specifies what jurisdictions they may operate in, and what type of vehicles and drivers that will be monitored under Alberta's National Safety Code Program. The two types of OS are:

- "Provincial" authorizes a carrier to operate only point-to-point in Alberta. A carrier with this OS may NOT leave the province.
- "Federal" authorizes a carrier to operate anywhere in Canada. (Point-to-point within Canada or to/from the US border).

Carriers must ensure that they operate under the proper OS. Carriers found operating in or outside of Alberta without the proper OS may be charged with an offence, be issued an administrative penalty, and have their vehicle detained.
